Short description	Employers, legal associations; public and independent organizations for child and youth welfare located in Brandenburg are eligible for this grant, which subsidizes training measures up to 50% of the eligible expenditure. Eligible types of training include professional further training measures for employees and business owners who work in a permanent establishment. Tuition fees (for courses and exams) are considered eligible costs. The requested grant must be at least EUR 1 000. The grant per application may not exceed EUR 3 000 per participant. There is no limitation for reusing the grant.
