| Short description | <p>The aim of the scheme is to reskill people in areas where there is evidence of job opportunities, including ICT, high-level manufacturing, international financial services, skills to trade internationally, cross-enterprise skills, entrepreneurship, innovation, digital marketing, and project management. Springboard+ was formed in 2014, with the incorporation of ICT Skills Conversion Courses. A feature of Springboard+ is the mixture of provision from the public and private higher education sectors. Providers are higher education colleges with established quality assurance systems, including Irish universities, institutes of technology, and private higher education colleges. For people in employment, a 10% course fee contribution for Level 7, 8, and 9 courses is applicable, payable directly to the provider. There are no tuition fees for DEASP customers or Returners. All Level 6 programmes are free to all participants.</p> |
