Background

The Department of Secondary Technical and Vocational Education and Training (STVET) of the Ministry of Education, Sport and Youth (MESY) is in the process of upgrading its infrastructure and using digitalised services to improve communication between VET graduates.

Objectives

To bring former students together, in order to maintain links with their school and fellow graduates through an online community platform.

Description

The online alumni community platform is a network of graduates from all the pathways offered by the Department of Secondary Technical and Vocational Education and Training. It will give VET graduates the opportunity to stay engaged with the department. Through networking and professional development opportunities, graduates will participate in and benefit from career insights and advice from other alumni and career professionals. Alumni can benefit from continuing education opportunities, career support and building stronger social networks. The Department of STVET can benefit from increased alumni connection to their programmes of study and more networking opportunities. The platform will give the opportunity to graduates to exchange messages, upload career and professional development opportunities, participate in teams and discuss topics of interest. The administrator will have the opportunity to inform users about vocational education and training events, create polls, and other relevant actions.

By registering on the VET-Employers' Matching Platform, users will also have access to the Alumni Community Platform.

2022 Implementation

In 2022, a contract was signed with an external contractor for the development of the platform and the design of the platform started.

2023 Implementation

By the end of 2023, 70% of the contract's content had been implemented (Treasury - Public Procurement Directorate, 2021): Project delivery - Installation - Staff training.

2024 Implementation

In 2024, the final phase of the contract began, which involves providing technical support for the platform's first year of operation.

2025 Implementation

In 2025, the Contractor successfully delivered training to a designated officer, to ensure effective operation and management of the platform, which is expected to be operational in early 2026.
