


Expert group proposal on measures to support students in facing challenges of COVID-19 pandemic

Background

The government has to ensure that students receive good follow up during the pandemic. A fast working, expert group has been assigned to assess and recommend measures, focusing especially on students' mental health, examinations and completion of studies.

Objectives

The objective is to ensure students' welfare, including VET students at vocational colleges (EQF level 5), social contact with each other and ensure that they complete their studies.

Description

The expert group is led by the Ministry of Education and Research and Universities Norway (UHR), the National Council for Higher Vocational Training, the Norwegian Directorate of Health, the Norwegian Institute of Public Health and student representatives. Students and the community council will also be involved in the work.

There have been regular meetings with all principals, students and organisations since March 2020 to map concerns, to discuss possibilities for improving the situation and to share good examples.

Over four weeks, the group worked to find beneficial solutions for students and its report suggested several measures to ensure student welfare:

- (a) more systematic follow up and information to students;
- (b) establish seminar groups of cohorts, with regular meetings on campuses when the COVID-19 situation allows;
- (c) social activities within the restrictions of the pandemic;
- (d) a national portal to exchange experiences;
- (e) more student-active teaching;
- (f) alternative training possibilities;
- (g) increased capacity for mental health care.

2020 Implementation

Some measures were in the design phase and some were in the implementation phase.

2021 Completed

A new report was published on measures for undelivered learning due to the COVID-19 pandemic. Many learners in vocational education and training did not receive work-based learning due to pandemic restrictions. The working group suggested, amongst other measures, a reinforced programme for learners without an apprenticeship placement. The alternative is improved training in school. The county municipalities received extra funding to facilitate the training.
