



# Decree on the methods and conditions for ensuring the rights of persons with international protection

# **Description**

In December 2017, the Slovenian Government passed the Decree on the methods and conditions for ensuring the rights of persons with international protection.

To help with the integration into the local environment, the Government Office for the Support and Integration of Migrants, in cooperation with a person with international protection, prepares a personal integration plan. The plan is based on the needs, knowledge, skills and abilities of the person. It includes various activities related to education and employment, recognition of education, accommodation and participation in a Slovenian language course and learning about Slovenian society.

In order to enrol into the programmes of upper secondary vocational or general education, an international protection beneficiary who cannot attest their formal education with documents has to pass a proficiency test and gain a certificate issued by the National Education Institute; (s)he must also fulfil the enrolment conditions where the selected programme requires them. The same certificate can also be used as appropriate proof by persons who cannot attest their formal education with documents and wish to obtain the national vocational qualification for which, at least, primary education is required.

The proficiency test includes the examination of general knowledge in social sciences, literature, arts and humanities, natural and mathematical literacy and communication in the English language. The cost of the test is covered by the Government Office for the Support and Integration of Migrants. An individual can undertake the test three times, after that must pay for it themselves. In order to enrol into higher vocational education and university study programmes, an international protection beneficiary who cannot attest their formal education with documents has to pass a proficiency test and gain a certificate issued by the National Examinations Centre, as well as aptitude tests where the selected programmes require them. The same certificate can also be used as appropriate proof by persons who cannot attest their formal education with documents and wish to obtain the national vocational qualification for which, at least, general secondary education is required.

The proficiency test consists of two examinations, comprising written maths exam and written and oral English language exam. The test can also be conducted in the English language, and it examines knowledge on the basic level of general secondary education.

Tests are organised as February and June exam periods. If an individual fails to pass one

examination, (s)he can undertake it again in the next exam round. The Government Office finances the test twice (both times with an option of a repeat), afterwards it is self-payment.
