Background

Upper secondary VET programmes are offered in four sectors: green/agriculture, technology, economics and care and welfare. Two equivalent learning pathways are running in parallel: in the school-based pathway, students spend at least 20% of their time on work placement while the dual pathway often involves four days' work a week and one day at school. The need to test alternative VET pathways combining both tracks comes as a follow-up to the Technology pact (*Nationaal techniekpact*) and the Focus on craftsmanship 2011-15 action plan (*Focus op vakmanschap*).

Objectives

The pilot is intended to address the need of VET schools and companies for more flexibility between VET tracks (school-based VET/BOL and dual VET/BBL) and to stimulate cooperation between schools and companies to offer good quality training that suits labour market needs.

Description

Pilots integrating the school-based (BOL) and dual/apprenticeship track (BBL) are referred to as GLBB (*Gecombineerde Leerweg BOL/BBL*). They are taking place between May 2015 and July 2021 in upper secondary VET schools (*middelbaar beroepsonderwijs* at MBO levels 2 to 4). They are being run under the cooperation of the Council for upper secondary VET schools (*MBO Raad*) and the Cooperation organisation for VET and the labour market (SBB). Students start in the school-based track and switch to the dual track after having obtained the relevant theoretical and practical skills.

The first results in 2018 showed that although the number of participants was still low (23 VET courses, 300 participants), the pilots met the needs of employers and learners. The government has called on all VET actors to collaborate to offer more dual training places, especially in sectors where dual VET is less common or has no historical roots.

The final evaluation of this pilot is expected in 2021.

The 2020 progress report shows that throughout the entire period 67 applications were submitted, of which 48 were granted and 41 actually started. About a quarter have gradually stopped, mainly because of too low an intake or the preference of companies and students for regular apprenticeships (BBL). The remaining programmes 'Combined VET learning pathways' (*Gecombineerde Leerweg BOL/BBL -GLBB*) jointly have an annual intake of approximately 450 students.

The cooperation between school and company/companies in some of the GLBB courses is intensive. Having to enter into a cooperation agreement has contributed to this because agreements have been made from the start and there is regular consultation and evaluation. In other words, the intensive cooperation leads to educational innovation.

In some of the GLBB courses, intensive cooperation and a higher quality of education are not on the agenda. Not much has changed in the content and design of these courses, at least not because of the GLBB.

2021 Completed

As of August 2021, the pilot GLBB has been nationally adopted. From that point, all VET colleges are allowed to offer a combined learning pathway 'BOL-BBL'.
