## Background

This Franco-German pilot was a first step before broader implementation is considered, which would involve encouraging other bilateral initiatives within the European Union, especially at European level. It aims to find concrete solutions to issues that may hinder young people when it comes to international placements in Europe, especially for apprentices. These issues include the duration of placements and the pace of work-study alternations, language barriers, the evaluation of apprentices, the recognition of professional qualifications and funding.

## Objectives

Strengthening the professional aspect of Erasmus, in order to enable young apprentices to benefit from the same opportunities for international mobility as students and thereby democratise and amplify the mobility of young people around Europe.

## Description

A French-German pilot project to support the mobility of young apprentices was launched in November 2015 and involved 50 young apprentices working in 11 participating large enterprises (Allianz, Michelin, Danone, Bosch, BASF, L'Oréal, Siemens, BNP Paribas, ENGIE, Airbus and Safran). The main aim was to raise awareness about apprenticeship among education and counselling staff in charge of school pupils. The initiative was supplemented by an online continuous professional development course for teachers and school guidance counsellors.
