Dear Colleagues,

I am pleased to invite you to the 32nd Session of the Section of International Organisations (SIO) of the International Council on Archives (ICA). Marc Willem, Librarian and Archivist of the European Centre for the Development of Vocational Training (CEDEFOP), has kindly offered to host the meeting, which will take place from the 26th to the 29th of September 2006 in Thessaloniki, Greece.

The provisional agenda of the SIO meeting is attached for your consideration and comment. Part of the meeting will focus on traditional items, including ICA business, the SIO website and guide, and so forth. In response to suggestions from several members, the amount of time devoted to the "tour de table" has been extended to give participants ample time to inform the Section about developments in their organisation. Additionally, the results of the SIO membership survey on electronic records management practices will also be presented by Ms. Anne Crétal and Ms. Monserrat Canela.

Most of our organisations are now facing increasing pressure to become more open, transparent and accountable by facilitating public inquiries into the operations of the organisation in a manner that is consistent with public expectations for global governance in the 21st century; in response organisations are developing information disclosure regimes which, in turn, are having a direct impact on archives and records management programmes. We will examine practices and lessons learned in one financial institution, the European Central Bank, as well as at the United Nations Secretariat.

If we believe what we read, Enterprise Content Management (ECM) "solutions" are going to solve all our problems by helping organizations create, capture, manage, and archive the vast amount of digital content that exists across the enterprise. A one-day workshop will examine, from the archives and records management perspective, the infrastructure and collaborative approach needed to needed to deploy these technologies, and will equip us to participate in ECM initiatives in our organisations.
