Groupings, irrespective of their legal form, may submit bids. Tenderers may, after forming a grouping, submit a bid on condition that it complies with the rules of competition. Such groupings (or consortia) must specify the company or person heading the project and must also submit a copy of the document authorising this company or person to submit a bid. If awarded, the contract will be signed by the company or the person heading the project who will be, vis-à-vis CEDEFOP, the only contracting party responsible for the performance of this contract. Tenders from consortia of firms or groups of service providers, contractors or suppliers, must specify the role, qualifications and experience of each member or group.

III.1.4) Other particular conditions to which the performance of the contract is subject:

Proposed subcontractors have to be approved by the Cedefop either by accepting the contractor's offer, or, if proposed by the contractor after contract signature, by an exchange of letters. The subcontracting will be accepted only if it is judged by Cedefop to be necessary to complete the project, and does not lead to distortion of competition. If awarded, the contract will be signed by the tenderer that will be the only contracting party responsible for the performance of the contract.

The tenderers must indicate clearly in their methodology, which parts of the work will be subcontracted, and the identity of all subcontractors undertaking more than 10 % of the work by value. Where no subcontractor is given, the work will be assumed to be carried out directly by the tenderer.

Tenderers must indicate in which State they have their headquarters or domicile and to present the supporting evidence normally acceptable by that country's law. In addition, they should provide evidence of their inscription in the professional/trade register (if applicable).

Exclusion of tenderers:

Grounds for exclusion:

To be eligible for participating in this contract award procedure, tenderers must certify that they are not in one of the situations listed below:

- a) they are bankrupt or being wound up, are having their affairs administered by the courts, have entered into an arrangement with creditors, have suspended business activities, are the subject of proceedings concerning those matters, or are in any analogous situation arising from a similar procedure provided for in national legislation or regulations;
- b) they have been convicted of an offence concerning their professional conduct by a judgement which has the force of 'res judicata';
- c) they have been guilty of grave professional misconduct proven by any means which the contracting authority can justify:
- d) they have not fulfilled obligations relating to the payment of social security contributions or the payment of

taxes in accordance with the legal provisions of the country in which they are established or with those of the country of the contracting authority or those of the country where the contract is to be performed;

- e) they have been the subject of a judgement which has the force of 'res judicata' for fraud, corruption, involvement in a criminal organisation or any other illegal activity detrimental to the Communities' financial interests;
- f) following another procurement procedure or grant award procedure financed by the Community budget, they have been declared to be in a serious breach of contract for failure to comply with their contractual obligations. Contracts may not be awarded to tenderers who, during the procurement procedure:
- are subject to a conflict of interest,
- are guilty of misrepresentation in supplying the information required by the contracting authority as a condition of participation in the contract procedure or fail to supply this information.

Means of proof required:

Cedefop will accept, as satisfactory evidence that the tenderer is not in one of the situations described in point a), b) or e), production of a recent extract from the judicial record or, failing that, a recent equivalent document issued by a judicial or administrative authority in the country of origin or provenance showing that those requirements are satisfied.

Cedefop will accept, as satisfactory evidence that the tenderer is not in the situation described in point d) above, a recent certificate issued by the competent authority of the State concerned. Where no such certificate is issued in the country concerned, it may be replaced by a sworn or, failing that, a solemn statement made by the interested party before a judicial or administrative authority, a notary or a qualified professional body in his country of origin or provenance.
