Speaker Biographies

Peter Cassells is currently Chairperson of the National Centre for Partnership and Performance (NCPP). The NCPP was established by the government in 2001 to promote and facilitate workplace change and innovation through partnership and to contribute to a better quality of life for employers and employees alike. As former General Secretary of the Irish Congress of Trade Unions from 1989 to 2001, Peter Cassells was one of the main architects of the national social partnership agreements.

Miriam David is Professor of Sociology of Education and Associate Director (Higher Education) of the Economic and Social Research Council's Teaching & Learning Research Programme (TLRP) at the Institute of Education University of London. In this capacity she is responsible for research projects on widening participation to and learning within higher education and issues around social diversity and difference across all levels of education, including lifelong learning.

Dr Barney O' Reilly is CEO of the Kerry Education Service (KES), the Vocational Education Committee (VEC) in Kerry. An Equality Review was undertaken by the KES in 2004 to conduct research on the management and implementation of equality issues, in order to define objectives for the implementation of an equality action plan in relation to KES employees and in the provision of educational services to its students.

Niall Crowley is the Chief Executive Officer of The Equality Authority since its establishment in 1999. Prior to this he worked in the community and voluntary sector on a wide range of equality issues. He has been a member of the National Economic and Social Forum (NESF) and the National Economic and Social Council (NESC). He is the author of An Ambition for Equality published by Irish Academic Press.
