The contract has the following main objectives:

— to map and comparatively analyse outcome-oriented approaches to curriculum policy and practice in initial vocational education and training (IVET), and

— to examine in depth the role of outcome-oriented approaches in curricula for facilitating or hindering learner-centredness and inclusiveness in teaching and learning processes.

This service contract (study) should provide an overview of outcome-oriented approaches to curriculum policies in the 32 countries participating in the education and training 2020 strategic framework ('ET 2020'), as well as an in-depth analysis of 15 case studies of how such policies are implemented in practice. The study should propose a typology of approaches examining — among other — the different understandings, roles and functions of outcome-based approaches in VET curricula, the methods used for curriculum design and stakeholders' involvement.

Based on this overview, the contractor will analyse in depth the practical implementation of 15 cases based on secondary (desk research) and primary data (qualitative 'in situ' research methods), to identify strengths and weaknesses and to analyse the relationship between outcome-oriented curricula and learner-centred and inclusive teaching and learning.
