#### RESTRICTED INVITATION TO TENDER

#### RPP/RES/GMA/Medical-services/001/12

'Provision of medical services to Cedefop staff'

I - As an EU Agency, Cedefop is part of the family of decentralised Community bodies. As such Cedefop must comply with the requirements set out in the Staff Regulations of Officials of the European Union and the Conditions of Employment of other servants of the European Union related to staff health such as, for example, pre-recruitment health checks and annual medical examinations.

Cedefop seeks to contract a Medical Officer who will assist it in fulfilling these obligations. The Medical Officer will work on Cedefop premises, in the medical station, where the necessary equipment for carrying out the duties is provided.

II - The volume of the required services described in this call for tenders is not expected to exceed **500** hours per year, therefore **2000** hours over a **4** year period. A Framework Service Contract shall be signed whereby the services will be provided following the signature of order forms within the context of the framework contract throughout its validity. The number and content of Order Forms will depend on the needs of Cedefop.

III –This is a two-stage procedure. All applicants meeting the requirements of the exclusion and selection stage (see III.2.1, III.2.2, III.2.3 of the contract notice and point IV below) will be included in a short-list. These applicants will, in a second stage, be invited to submit a tender and will be invited for an interview (approximately mid-September).

IV-The interested applicants must submit in a closed envelope the following documents in order to have their application assessed against the exclusion and selection criteria as stated in the Contract notice:

- Filled in and signed Declaration of honour with respect to the Exclusion Criteria and absence of conflict of interest;
- Copies of the tax declarations and of the relevant tax clearance statements delivered by the competent tax authorities for the last three financial years;
- Document for enrolment in the relevant professional register, as prescribed by the laws of the Member State, where the tenderer is established;
- Proof that the applicant is allowed to practice general and/or occupational and/or internal and/or emergency medicine in Greece (at the deadline for submitting tenders);
- Copies of the applicant's mandatory and non-mandatory insurance policies related to professional risks;
- The educational and professional qualifications of the applicant, including:

- a Curriculum Vitae, <u>including reference to the language skills</u> (the applicant may use the Europass CV attached as Annex or download it from the following link<sup>1</sup>);
- certified copy of the relevant degree(s) in medicine;
- proof that the applicant has been practicing general and/or occupational and/or internal and/or emergency medicine for at least 8 years,
- proof of occupational health qualification (this is for informative purposes only).

# V - Applications may be submitted in one of the following ways:

- (a) by courier service to be dispatched not later than 06/07/2012, in which case the evidence shall be constituted by the date of dispatch to the address below or the date of the deposit slip, or
- (b) **delivered by hand not later than 06/07/2012**, in which case a receipt must be obtained as proof of submission, signed and dated by the official in the above mentioned Service who took delivery,
