

Privacy Statement on the protection of personal data in relation to

Participation in an online questionnaire as part of the working paper entitled, “Inclusion in Greek IVET: The case of gendered language and socio-pragmatic strategies in promotional VET material”

All personal data are processed in accordance with the provisions of Regulation (EU) 2018/1725 of the European Parliament and of the Council of 23 October 2018 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data, and repealing Regulation (EC) No 45/2001 and Decision No 1247/2002/EC (hereinafter – Regulation 2018/1725).

1. Who is the controller regarding the processing of your personal data?

The controller is Cedefop and the responsible entity is DVQ.

2. What is the purpose of processing your personal data?

The purpose of the data processing is connected to investigating the attitudes of prospective VET students in relation to the language used in Greek promotional VET material. To this end, the social profile of each participant is also useful, in order to obtain a complete picture of the background of each participant as they are representatives of the chosen group based on level of education, nationality and age that needs to be considered.

3. What personal data are collected and processed?

The following personal data are processed to identify the group of respondents: Gender, date of birth, place of birth, nationality(ies), languages spoken, school class attended, area of residence, parents' occupation (optional), views and opinions. Answers to all questions in the questionnaire are anonymous.

What is the legal basis for the processing of your personal data?

The legal basis for the processing activity is:

Article 5(1)(d) of Regulation (EU) 2018/1725 – the data subject has given consent to the processing of his or her personal data (that are part of the questionnaire) and for subsequent publication of the working paper on Cedefop's webpage.

4. Who has access to your personal data and to whom they are disclosed?

Internal recipients

- The researchers of the paper, under DVQ as designated Cedefop staff responsible for research on the specific topic.
- Cedefop's staff internally responsible for audit and review activities, as well as staff of external entities providing audit and review services to Cedefop may have access to the

personal data collected through this processing operation, to the extent necessary for carrying out their activities.

- Staff members in DCM who are responsible for editing and publishing of the working paper.
- Any reader of the working paper

External recipients

The provider of the EU survey (European Commission) will have access to our data.

5. For how long are your personal data kept?

Personal data will be kept up in an online copy (saved in collaboration space) to a maximum period of 6 months from the time that the working paper is published.

6. Are there any transfers of your personal data to countries outside the EU/EEA?

7. What are your rights and how can you exercise them?

You have the right to request from the controller access to and rectification or erasure of your personal data or restriction of processing.

Consent to any of the related processing activities may be withdrawn at any time, without undermining the lawfulness of processing undertaken until that point.

The controller shall provide information on action taken on a request within one month of receipt of the request. That period may be extended by two further months where necessary, taking into account the complexity and number of the requests.
