and outcomes	The department supports policy development and provides evidence for policy making to help modernise vocational education and training (VET) systems.
	The VPS team monitors, analyses, and reports on progress in priority areas for VET that EU Member States, Norway and Iceland have set for VET. These priorities are described in the Council <u>Recommendation</u> <u>on vocational education and training</u> for sustainable competitiveness, social fairness and resilience and in the <u>Osnabrück Declaration</u> on vocational education and training as an enabler of recovery and just transitions to digital and green economies.
	In 2024-25, the VPS team will analyse policy developments in VET and lifelong learning in line with the countries' <u>national plans</u> on how they plan to implement the agreed priorities in the Council Recommendation and Osnabrück Declaration.
	The team analyses and synthesises qualitative and quantitative information mainly provided by <u>ReferNet</u> (Cedefop's European network for expertise on VET which includes key institutions dealing with VET, VET policy and/or research). Other Cedefop, European and international sources are also used.
	This work requires collaborating with colleagues in house and external partners, for instance the European Commission, national ministries, employer and employee representatives.

	The team publishes online descriptions and concise information ('spotlights') on the main features of VET,
