VII.2.1) Description of the modifications

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

The purpose of increasing the overall ceiling of the FWC is to ensure the continuity of the provision of external engineering consulting services and supervision of projects related to the maintenance, renovation and refurbishment of the building and the infrastructure.

Due to the recent energy crisis and given the post covid-19 working conditions, Cedefop adapted its strategy regarding the implementation of energy efficiency solutions. Specifically, projects such as the installation of photovoltaic panels or the technical study for the construction of a green roof, took priority and resulted to a faster consumption of the framework contract envelope. At the same time, the on-going study on climate neutrality by 2030 shall probably foresee the implementation of additional energy efficiency projects which shall require additional engineering, consulting and supervision services. It is obvious that the effort required for the implementation of these activities could not have been foreseen at the time when the current framework contract was signed.

The relevant amendment was signed on 22 June 2023.

In point 1.5 of the tender specifications of the cited in subject contract the provision of increasing the financial envelop of the framework contract was foreseen by the following paragraph: 'In the case where unforeseen circumstances result in the global value of this contract being consumed faster than originally planned, Cedefop reserves the right to consider conducting a "Negotiated procedure without prior publication of a contract notice" with the existing contractor(s) in order to increase the maximum amount stated above by up to 50 % (Point 11.1(e) of Annex I to the EU Financial Regulation (FR)'.
