VII.2) **Information about modifications**

VII.2.1) **Description of the modifications**

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

The purpose of this negotiated procedure is to ensure the continuity of the provision of external resources to help Cedefop ICT Service to ensure the configuration, good functioning and the evolutionary maintenance of the SharePoint (M365) installation and its modules as well as the development of new electronic workflows with FlowForma.

By the end of 2022, it is foreseen that M365 tools (SharePoint, Teams, OneDrive, FlowForma) will replace the existing Livelink installation and its modules (i.e. records bank, collaboration workspace, intranet, workflows). Although a feasibility study and a migration planning were originally foreseen during the initial estimations, the

effort required for the implementation of these migration activities could not be foreseen at the time when the current framework contract was signed.

An award notice has been signed on 14 April 2022 and an amendment was signed on 19 April 2022.

VII.2.2) **Reasons for modification**

Need for additional works, services or supplies by the original contractor/concessionaire (Art. 43(1)(b) of Directive 2014/23/EU, Art. 72(1)(b) of Directive 2014/24/EU, Art. 89(1)(b) of Directive 2014/25/EU)

Description of the economic or technical reasons and the inconvenience or duplication of cost preventing a change of contractor:

In Point 1.5 of the tender specifications of the cited in subject contract the provision of increasing the financial envelop of the framework contract was foreseen by the following paragraph: 'In the case where unforeseen circumstances result in the global value of this contract being consumed faster than originally planned, Cedefop reserves the right to consider conducting a "negotiated procedure without prior publication of a contract notice" with the existing contractor(s) in order to increase the maximum amount stated above by up to 50 % (Point 11.1(e) of Annex I to the EU Financial Regulation (FR)).' This procedure can be used only in case of a repetition of similar services, provided these are in conformity with the basic project, at the latest during the three years following the signature of the contract and only if this possibility was announced from the outset of the initial procedure.
