

Introduction

The workshop ‘Microcredentials and the future of learning’ will explore the diversity (profile and function) of microcredentials beyond formal education and training, as well as the role of quality assurance and recognition. Participants will be presented with initial insights from Cedefop’s ongoing [research](#) during the plenary and interactive breakout sessions. Discussions will aim to position microcredentials in relation to specific labour market sectors and address their potential use and accessibility for promoting social inclusion, particularly among disadvantaged groups and individuals.

The event will bring together policymakers, stakeholders, experts, and researchers to reflect on the role of microcredentials in redefining learning and working in the 21st century. A dedicated session with Cedefop’s [ReferNet](#) network will be held live during the [ReferNet Plenary](#), where members will present findings from their reporting on microcredentials.

Workshop objective and aims

The workshop sets the stage for an open and forward-looking discussion on the evolving role of microcredentials in supporting labour market needs and employment-relevant learning – including in the context of vocational education and training (VET). As microcredentials gain traction in education and policy, the workshop offers a timely opportunity to explore their potential to respond to the demands of fast-changing labour markets, digital transformation, demographic shifts, and a growing need for reskilling and upskilling.

The workshop will introduce participants to the methodology and the main research questions of Cedefop’s ongoing study on microcredentials. It will provide valuable insights into current trends, challenges, and opportunities. As well as sharing research, the workshop serves as a collaborative space for dialogue, reflection, and exchange – inviting contributions to shape future research priorities and discuss the next steps in Cedefop’s work in this dynamic area.

Participants will have the opportunity to take part in **four breakout sessions**.

- ✓ **Breakout session 1 – Shaping skills for tomorrow: microcredentials and the labour market** will address the role microcredentials play in improving skills utilisation and career development.
- ✓ **Breakout session 2 – Building trust: the power of quality assurance in microcredentials** will examine how quality assurance mechanisms can ensure the quality of microcredentials issued by different types of providers.

- ✓ **Breakout session 3 – Global credentials: making microcredentials recognisable and portable** will focus on inconsistencies in the recognition and portability of microcredentials across sectors and borders.
- ✓ **Breakout session 4 – Uncharted microcredentials: digital innovations beyond formal education** will focus on the main features (content, profile, digital format) of microcredentials in European labour market-related education, training and learning.

As microcredentials evolve beyond an educational tool to become a powerful policy instrument, their potential to address urgent global challenges – ranging from digitalisation and e- and up-skilling of the workforce to skill gaps and labour market shifts – is coming into sharper focus. Leading experts and innovators in microcredentialling will share ideas from their current work and present their forward-looking visions.

Join us for a thought-provoking discussion on how microcredentials can reshape lifelong learning, drive inclusive workforce development, and build more agile, future-ready societies.
