In support of the implementation of the Pillar, Cedefop has developed the European Skills Index (ESI) which aims at monitoring the performance of Europe's skills systems, while at the same time identifying areas calling for improvement.

Croatia: new model of skills competitions launched in 2019



Over 580 VET students competed in WorldSkills Croatia. where demonstrated their abilities in 43 disciplines. These included, for the first time, categories for students with disabilities and cross-

sectoral disciplines in technologically progressive industries, such as robotics and mechatronics. Practical and team work tasks were at the heart of this year's event, which attracted more than 10 000 visitors. Read more here.
